We have also issued a statement, on behalf of Seas Suas, reacting to the announcement by the Minister yesterday evening. While we have welcomed the additional guidance, we have once again expressed our disappointment at the lack of any detail on funding and support for the sector.

Our document was shared with the Minister who acknowledged some of the recommendations we had provided in her own interview on RTE Drivetime when she was questioned on the issues and challenges we have raised.

Most importantly, in her announcement, the Minister openly recognised our calls for the need to engage with the Minister for Finance and Public Expenditure on a funding model to support the phased reopening of childcare services

I attended DCYA Advisory Group meeting yesterday where the DCYA provided an overview of what the minister was taking to Cabinet in the afternoon. This provided an opportunity to bring our messaging across further and we are confident that our voice has been heard.
